

Publishing Agreement

This document outlines the rights of publication and distribution for the book *The Geology of Colombia*. This is an agreement between the author(s) (equivalent to author and coauthors) and the Servicio Geológico Colombiano (SGC) in order to grant the SGC the chapter's copyrights and thus the rights to publish and reproduce the book, chapter(s), or any parts therein. The main (and/or corresponding) author is obligated to share this document with all coauthors.

Originality of Text


The author(s) was (were) called to present original work (new results, data or ideas) or a compendium of the author's unpublished work, which neither have been published elsewhere nor are under consideration for publication by any other editorial and will not be submitted for such review while under review by *The Geology of Colombia* editorial board. Paraphrasing substantial parts of another work and similar practices are un-acceptable.

Copyright

The author(s) has (have) the right to the proper attribution and credit for the published work. Nevertheless, the SGC is granted the right to publish and distribute the book or any part of it in digital (publish the book and chapters on SGC's online platform), physical (printed book), or any other media, in any form, in any language, in any country. The author(s) is (are) responsible for acting accordingly, in an ethical manner.

Distribution

The Geology of Colombia book will have **free distribution**; thus, the author(s) and the SGC will distribute the book or chapters for free (including manuscript, figures, tables, supplementary material, and all material submitted for publication purposes). Any profitable activity will be sanctioned, as the book is not intended for commercial use. The book and chapters can be used for personal, institutional, and scholarly sharing purposes; thus, the authors can promote the book and their chapters through their personal or institutional pages. Similarly, the book or chapters can also be distributed en masse. Pre-publication online or through any other media is not allowed until the book has been published by the SGC.



The SGC will present and distribute the book at different meetings such as Colombian geological congresses, international geological congresses, SGC's scientific and technical meetings, GSA meetings, and Commission for the Geological Map of the World meetings.

Errors in Published Chapters

If errors are detected in the manuscripts, the author(s) should communicate and collaborate with the editorial board of the book to correct the mistakes.


Preserving Reputation

The authors, the editorial board of the book, the reviewers, and the SGC in general are responsible for the reputation of the book; thus, they must defend their work and their reputation.

Plagiarism and Other Infringing Activities

Chapters submitted to/published in *The Geology of Colombia* book do not contain libelous or other unlawful statements and do not contain any materials that violate any personal or proprietary rights of any other person or entity. The author(s) has (have) not engaged in plagiarism or any other kind of infringing activities in writing the text or elaborating the figures of the submitted chapter. Thus, the author(s) has (have) provided all the required credits, has (have) obtained all written permissions from copyright owners for any excerpts from copyrighted works that are included, and has (have) credited these sources in the chapter and acknowledged them in the **Submission letter**. Furthermore, the author(s) has (have) not selected data with undue bias, fabricated data, or engaged in any illegal activities. The author(s) is (are) responsible for the certainty of the data. Moreover, manipulating the citation (adding unnecessary citations to increase an author's or a journal's citations) will not be accepted. If any personal details are used, the author(s) has (have) obtained written permission or consent from the individual(s) in question (or, where applicable, the next of kin).

Conversely, the SGC has the authority to enforce the rights on behalf of authors against third parties in the case of plagiarism, copyright infringement, reputation damage, etc. If an author(s) becomes aware of potential plagiarism or any other infringement, he (they) is (are) encouraged to contact the SGC so the legal office can evaluate the situation and take necessary actions.



Publishing Agreement Is Retroactive

If the SGC considers any changes in the **Publishing Agreement**, those will be retroactive.

Agreement

The author(s) must send this document signed to the e-mail thegeologyofcolombia@sgc.gov.co to express that he/she (they) has (have) read and accepted all the content of this **Publishing Agreement**. The author must inform any coauthor(s) of the terms of this document and act on behalf of all coauthors of the manuscript as their agent; the author represents that he/she is authorized to do so. In addition, the author(s) must act without any conflict of interest with his/her (their) university, institution, or the given author's (authors') filiation.

Breaches of the Agreement

Any breach of this agreement will be discussed by the SGC, and sanctions will be taken according to the consideration of the SGC, such as definite rejection of the manuscript.
