Document on paper support, vertical format, consisting of a folio with printed and handwritten script in italic script on the recto and verso. The document uses stamped paper with the inscription "*Dos reales / Sello quinto, para los años / de 1838, y 1839*" (Two reals / Fifth stamp, for the years / of 1838, and 1839). On the upper left-hand side there is a circular seal with a thick border with the text "*ESTADO NOR-PERUANO*" and the National Coat of Arms printed on it; on the recto side there is a printed rubric, as well as the original foliation "*675-7*". On the recto side is the first section of a testamentary deed, while the verso side continues with the testamentary clauses. This is a fragment of the will of the presbyter [*José*] Velasco, granted between 1838 and 1839 in Huacho. It is in fair state of preservation, with stains, pitting and some letters burnt by ink; the document is part of a larger file.

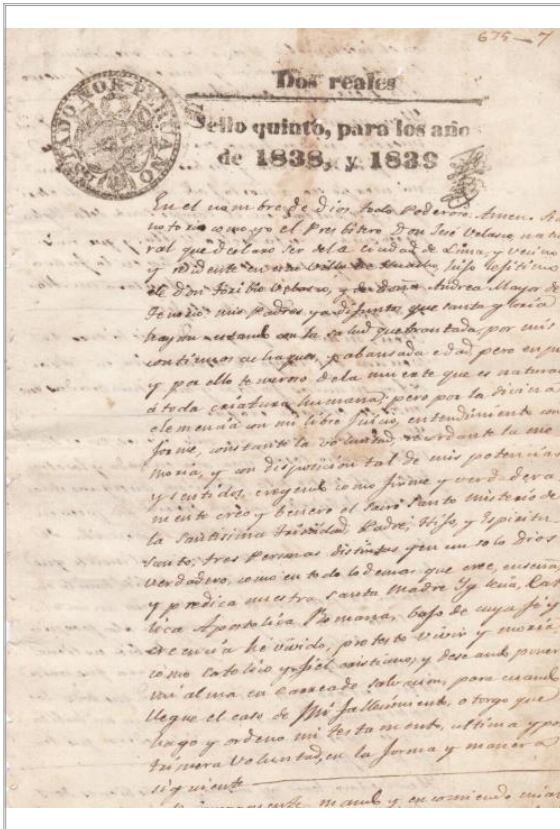


Image: Previous View

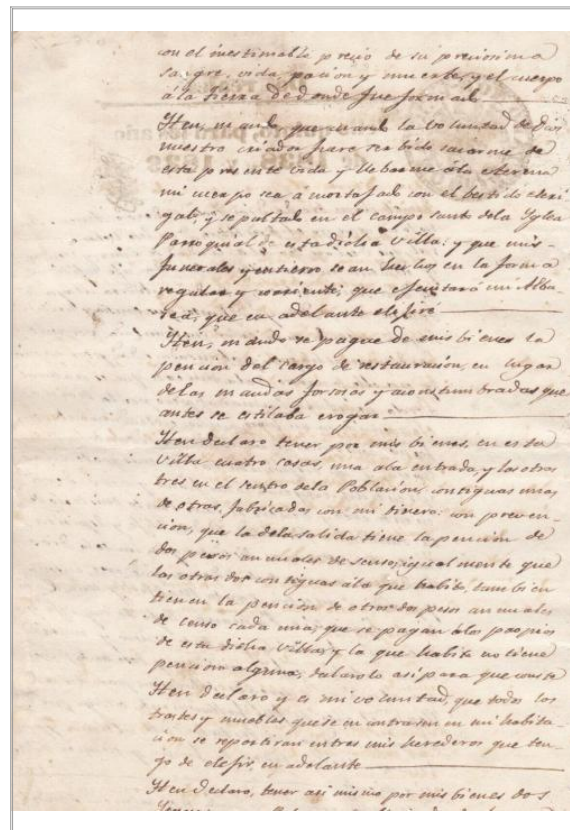


Image: Back View
